# **Capital Project Motion**



#### Be it resolved that:

Council move forward with a Capital Expansion Project. The Project will include the following:

- Installation of a new vestibule and drop-off canopy at the Worship Center entrance
- Expansion of the Narthex and installation of a glass wall between the Narthex and the Nave
- A 20' x 40' expansion of the Nave with emergency exits
- New furnishings, finishes, lighting and audiovisual equipment for the Nave and Narthex
- Creation of two unfinished classrooms in the lower level
- Installation of a Limited Use Limited Access (LULA) lift
- Installation of an ADA approved ramp to allow handicapped access from the upper parking lot

Total cost of the project including the current debt on the Worship Center HVAC system not to exceed \$1.8 million.
