ANNUAL MEETING MINUTES

FEBRUARY 5, 2023

12:00

- I. Opened in Prayer at 12:07pm by Pastor Mark Wimmer.
- II. Called to Order by Mark Stanziola, Congregational Council President with Amy Grubb as Secretary. Members were in person in the Sanctuary or on Zoom monitored by tech support.
 - A. Mark began with opening remarks, recognizing all that helped make the building renovations a reality, to allow growth to happen.
 - B. He recognized many challenges over the past year, including resuming in person worship after a pandemic with the help of the technology team, transition to a new Financial Director, and the retirement of Pastor Ric Elliott as senior pastor.
- III. **Motion**: To approve the adoption of the agenda (refer to the 2022 Annual Report) by Amy Grubb with a second by Mike Epperly. **APPROVED**.
- IV. **Motion**: To adopt the 2022 Annual Congregational Meeting Minutes as reviewed and approved by Congregational Council on February 11, 2022 with a second by Deb Stevens. **APPROVED**.
- V. Reports
 - A. Highlight from the Interim Senior Pastor report were shared by Pastor Mark Wimmer (full printed version on page 9-10 of the Annual report). No questions followed.
 - B. Mission Team Reports: Refer to pages 15-25 of the 2022 Annual Report where the Mission Team summaries are outlined. No questions followed.
 - C. **Motion**: To adopt the 2022 Annual report by Carolyn Epperly with a second by Chuck Coe. **APPROVED**.
- VI. Elections
 - A. Recognition of current Congregational Council members (Mike Berkheimer, Dean Black, Faye Casciano (Vice President), Mike Epperly, Kristin Ervin (Member at Large), Amy Grubb (Secretary), Sue Mathieu, Nina McNally, Denise Rohrbach, Mark Stanziola (President), Hayden Fermier - Youth Representative).
 - B. Recognition of departing Congregational Council members Bob Stevens and Chris Pirrotta. Thank you for your service.
 - C. Nomination of Bob Bolen as a 2023 Congregational Council Member. Motion to approve this nomination by Dave Hirshel with a second by Chuck Coe. **APPROVED**.
 - D. There is still one Congregational Council vacancy. No nominations were offered during Annual Meeting. Congregational Council has sufficient quorum, so they will continue with present members.
 - E. Re-Election of Kristin Ervin and Faye Casciano as Congregational Council members and Hayden Fermier as Youth Representative to Council. Motion to re-elect these members by Christine Bolen with a second by Rick Doty. **APPROVED**.

- F. Election of Synod Assembly Delegates:
 - 1. **Motion**: To approve the nomination of Ricki Stringfellow as Synod Assembly Delegate for 2023 by Chuck Coe, with a second by Barb Roba. **APPROVED**.
 - 2. **Motion**: To approve the nomination of Rick Doty as Synod Assembly Delegate for 2023 by Chuck Coe, with a second by Dan Tobey. **APPROVED**.

VII. Old Business

- A. Update on Spirit Led / Spirit Alive Capital Campaign: The campaign officially ended as of 2022 but remains open to continue fulfilling pledges.
- B. In the planning phase, the Lower Level Construction Project had to be separated from the Spirit Led/Spirit Alive project due to inadequate financing. However Margaret Legenhausen's bequest to the congregation has allowed the Lower Level project to happen. The Limited Use Limited Access (LULA) elevator will be dedicated to her, with a date sometime after Easter. Construction on this project has now been completed. Nursery School will move downstairs over the summer to be ready for Fall 2023.
- C. Pastor Mark Wimmer presented thank you and acknowledgement to Wilbur Kemp, who will be retiring as assistant treasurer after 37 years. He was presented with a certificate and a gift.
- D. Mike Epperly reviewed final numbers of Spirit Led / Spirit Alive campaign and Lower Level Renovation Project. Discussed that balance in the Spirit Led / Spirit Alive campaign was used to reduce initial March 1, 2023 mortgage payment. Thank you to Chris Carter who was a leader in the Spirit Led / Spirit Alive project and the Lower Level project.

VIII. New Business

- A. Adoption of 2023 Budget -
 - Mark Stanziola provided an introduction that this was a challenging year in the setting of coming out of a pandemic and in the middle of a recession. The Finance Committee & Congregational Council have met multiple times to come up with the budget presented today. Deb Stevens & Teri Hinderliter were instrumental volunteers in creating the budget. Bob Stevens was available on Zoom for questions.
 - 2. Motion: To accept the 2023 budget by Chris Pirrotta with a second by Rick Doty. APPROVED.
 - Report/review from Finance Director Bob Mueller. Sherilynn Scheetz resigned end of August of 2022. Thank you to Teri Hinderliter and Deb Stevens who took on additional responsibilities and to Bob Schuchart for stepping in to fill this role until a replacement was found. Thank you to Mark Casciano for managing our Endowment accounts.
 - 2. Review of 2022 performance and presentation of 2023 budget including original proposal and revision.
 - a) Question from Barb Roba about what makes up the Special funds line item- Deb Stevens answered that these are special envelopes for Easter, Thanksgiving, etc.
 - b) Questions from Dave Rishell about the staff 2% bonus Bob Mueller clarified that this is a lump sum bonus.
 - c) Correction to slide titled 2023 Projected Operating cash should be 2023, not 2020.
 - d) Cash balance currently is \$49K, which is less than 1 month of expenses.

- e) Summary:
 - a) Deficit budget of \$20,879.
 - b) 2% lump sum bonus for non-Pastoral staff
 - c) Endowment fund to supplement:
 - a) \$25K for Budgeted Benevolence
 - a) Explained Ann Doyle Angel Network Memorials- one year only no donation to Angel Network for 2023. Will resume in 2024. Will continue in-kind donations.
 - b) \$6K for Catechetics
 - c) Up to \$5K for Call Committee
 - d) Council and Finance Committee propose a Second Mile Giving campaign to raise \$50,000 to alleviate the need for the ELCA Endowment subsidy of Budgeted Benevolence and eliminate the deficit.
 - e) Questions: Mark Casciano clarified 2020 revenue includes PPP funds from pandemic. Emphasized the revenue is the biggest challenge.
- B. Update on Call Process:
 - 1. Still in early phase of meeting. First step is completion of Ministry Site Profile (MSP).
 - 2. Open to alternative methods to find candidates.
 - 3. Chairperson is Bob Mueller. Other members: Craig Kauffman, Carol Osenbach, Kyle David, JoEllen Rooney, Kate Nesfeder (youth representative), and Amy Grubb (council liaison).
 - 4. Once candidates are presented to the Call Committee from the synod, the Call Committee will begin to vet the candidate.
 - 5. Overall the process is ahead of timeline originally presented by synod.
- C. Update on Ministry Site Profile Task Force this is the "resume" for the church that goes out to prospective pastors. Thank you Jen Day Roth for being the chair person and her hard work, and all the other members on the Task Force. On track for approval of Congregational Council by the February Staff/Council retreat.
 - 1. This will include an update to our website as this is how outsiders first will gather information about us.
- D. Initiation of "Second Mile" Campaign:
 - 1. Goal is to raise \$50,000 to alleviate the need for the ELCA Endowment subsidy of Benevolence and eliminate the deficit. Motion: to approve the Second Mile Campaign by Mike Epperly with a second by Kristin Ervin. **APPROVED**.
 - Zoom question from Bill Keane asking if Council can guarantee that Benevolence will not be used to supplement the deficit budget next year. Mark Stanziola states this is for this year, and not meant to be long term. Next year is unknown. It was not a decision taken lightly. Council will do their best to ensure this is a one time occurrence. Bob Stevens added that we did not cut Benevolence, we supplemented with \$25K from Endowment. Deb Stevens reports that we pay Benevolence in Dec - if we get enough with the Second Mile Campaign won't need to take it from Endowment.
- E. Chris Pirrotta asked about attendance numbers. Pr Tami Reichley replied that the 10:30 service is below pre-pandemic numbers. The 9:30 worship is flourishing. She thanked Karin Kahler for her hard work and dedication. There were 102 worshipers last week at the 9:30 service

- F. Kyle David asked if the church has looked int to he Employee Retention Tax Credit. The answer was not at this moment.
- G. Mike Yablonsky asked if total benevolence equaling 10% of total revenue is a requirement or just a goal. Mike Epperly states that it's an unwritten goal. Patty Bisbing notes that when congregational started goal was 1/3 benevolence.
- H. Patty Bisbing also notes that she does not know who the council and call committee members are. The installation of these members will be coming up in a future church service. Mary Jo Serfsas asked for those people to stand that were present at the Annual Meeting.
- Kyle David asked how are we going to know what our metrics of success are with the new renovation projects. Mark Stanziola noted a few: attendance, number of weddings, increased membership. Bob Stevens noted several objectives: 1) revise worship space to make more room for worship and music. The number of seats have stayed the same so increased attendance wasn't goal, the goal was to make it more welcoming. 2) To make the building more accessible by the community and other community groups 3) To move the Nursery School downstairs for more secure environment. Bob Stevens states we have achieved those objectives. There will be work to do with what to do with middle of the building to allow community use.
- IX. Closing Prayer by Pastor Mark Wimmer at 1:53 PM. Motion: To adjourn by Rob Sandoval with a second by Chuck Coe. **APPROVED**.

Nominating Mission Team

The Nominating Mission Team's role is to provide the Congregation with a slate of candidates to fill open positions on the Congregation Council. In addition, other candidates are nominated for delegates to the Synod Assembly. The team provides biographical information to the congregation on the potential Council candidates.

Mark Stanziola, Amy Grubb, Nina McNally, and Hayden Fermier (Youth Representative) have fulfilled their terms on Council, and are retiring from that commitment, with our gratitude for their leadership. Mike Epperly completed his 3-year term and has agreed to be nominated for an additional 3-year term. This leaves us with three (3) 3-year terms to fill for Mark, Amy, and Nina, plus a one-year term for a new Youth Representative. We also have a 1-year Council term to replace the remainder of Denise Rohrbach's service on Council.

The current nominees for open Council terms are:

- Rob Sandoval to fill a 3-year term
- John Osenbach to fill a 2-year term; John was approved by Council in February 2023 for a 1-year term; per our Constitution the Congregation needs to vote to elect John to Council for the next two years (2024 and 2025)
- Hannah S. to fill the 1-year term as Youth Representative
- Bob Mueller to fill the 1-year term remainder of Denise Rohrbach's council term. Bob will also replace Amy Grubb as the Council Liaison to the Call Committee during 2024.
- At this point we are still recruiting nominees for the two remaining three-year terms

The nominees for Synod Assembly Delegates (June 2024) are Rick Doty and Ricki Stringfellow. We continue to be grateful for all who serve our congregation in these important leadership roles. Thank you!

2023 Congregation Council Summary

The Congregation Council Annual retreat was held at Lutheran Church of the Holy Spirit on February 24, 2023. The Executive Council members were elected as follows: Mike Berkheimer as Council President, Mark Stanziola as Vice President, Kristin Ervin as Secretary, and Faye Casciano as the Member at Large of the Executive Council. At the Council retreat, the Council determined Mission Team Assignments and approved the appointment of Debra Stevens as Treasurer and Terri Hinderliter as Financial Secretary.

Actions by Council in 2023 included:

January

- Approved up to a maximum of \$5,000 from General ELCA Endowment Fund Pooled Trust to fund Call Committee expenses during 2023
- Approved up to \$25,000 if needed from General ELCA Endowment Fund Pooled Trust to supplement funding of Congregational Benevolence
- Approved disbursement from William S. Wotring Endowment Trust of \$6,000 to fund Faith Formation for Youth, Confirmation/Catechism expenses such as CAT Camp in 2023 budget
- Approve Finance Team recommendation to establish a new monthly mortgage payment for Mission Investment Fund (MIF) Building Project loan starting March 1, 2023. Finance will reduce the outstanding Principal loan balance utilizing cash donations available in SPIRIT LED / SPIRIT ALIVE CAMPAIGN account. MIF Building Project loan Principal balance becomes \$ 409,360 at 3.875% for 23 years. MORTGAGE REDUCTION account in 2023 Budget is \$22,433 which reflects new monthly payments of Principal / Interest of \$2,243.28 for last 10 months of 2023 after refinance of MIF Building Project loan completed
- Approved a revised 2023 budget to be presented to the congregation for approval at the February annual meeting
- Approved a motion to authorize a Second Mile Giving Campaign with target goal of \$50,000 with the intended purpose of increasing the operating balance and offsetting the Endowment contribution to Benevolence

February (Staff/Council Retreat 2-24-2023)

- Accepted resignation of Kristen Newill, Transitional Technology Associate, with regrets and best wishes
- Approved new Council members: Bob Bolen (3-year term) and John Osenbach (elected by Council to fill vacancy for 1 year; up for additional 2-year term with Congregation approval in February 2024)
- Approved Deb Stevens as Treasurer and Terri Hinderliter as Financial Secretary
- Approved Lenten collections to go toward ELCA World Hunger on behalf of Outreach
- Election of Council Executive Committee was completed:
 - President: Mike Berkheimer
 - Vice-President: Mark Stanziola
 - Secretary: Kristin Ervin
 - Member at Large: Faye Casciano

March

- Approved a Preschool Dine to Donate fundraiser as proposed by Faith Formation for Children
- Approved disbursement from William S. Wotring Endowment Trust of a grant not to exceed \$500 to partially fund the expense of a week at Bear Creek Summer Camp for a fifth grade student
- Approved the Ministry Site Profile (MSP) via email vote following discussion of the document at the February Council Retreat. The MSP is required as part of posting the position for Senior Pastor

April

Report of the Interim Senior Pastor:

Chris and Bob's positions were blended to create the position of Director of Operations. That position was filled last fall by Nadine Hohe. Welcome Nadine!

We learned through the year the need and support for small group ministry offerings and recognized in the response to our Lenten Services, Bible studies and Lunch with Pr. Wimmer. MISSION TEAM REPORTS

Faith Formation Ministries for Children

Convener – Leigh-Anne Wimmer

Our Education Mission – We are a congregation that values our children. We will prepare them to discover and grow in their faith formation with the support of parents, families, and our church community.

<u>Mission Team</u> – The mission team met for a total of 8 meetings this past year. The Team has responsibility for the following programs for children from birth to grade 5: Birth to Age Three Ministry; Sunday School; Weekday Nursery School; Vacation Bible School; Church Nursery; Bible Ministry; and GIFT (Growing in Faith Together).

Nursery School – Holy Spirit Christian Nursery School continues to maintain its reputation as a provider of a high-quality preschool education in the East Penn community. The 2022-2023 school year ended with a well-attended moving on ceremony for those going off to kindergarten. During the month of June the classrooms moved from the upper level of the building to the lower newly renovated classrooms. Thank you to everyone who helped with the move and the purchase of needed items. The 2023-2024 school year began with all staff returning to the new space and students/families loving the look. Nursery school students participate in a weekly chapel lesson, which is led by the pastoral staff and Karin Kahler. Some school wide events were held such as Sneak Peak, Halloween Parade, Thanksgiving Chapel where we welcomed families to participate, and Christmas Songfest.

<u>Vacation Bible School</u> –VBS 67 children participated in rotations throughout the morning following the message of the day. The Theme was Food Truck Party: Roll with God. 127 boxes of Pasta and 112 Cans of Fruit were donated to Grace Lutheran Church Food Pantry. 89 Stuffed Animals were donated to Pediatric Same Day Surgery at LVHN. Everyone had a great time and we received positive feedback.

<u>Sunday Morning Education</u> – Sunday Family Worship Service continued to be offered. Children participate by reading the bible story for the day, listening to a children's message, and singing songs. Sunday School classes are held following worship and are broken down by age/grade. First Holy Communion classes were held, and 11 students participated and received their First Holy Communion. The year ended with our annual Christmas Pageant. The following items were collected and donated to various projects:

80 Stuffed Animals in September for LVHN Same Day Surgery
Unknown amount of canned goods for Angel Network in October
\$129.75 for LCHS Stitch and Chat in November
25 hats and 32 pairs of gloves in December for clients at Grace Macungie's Food Panty
\$1,485.29 in offering which was given to God's Global Barnyard and Stitch and Chat

<u>Church Nursery</u> –Our caregivers continue to provide consistent, quality care at all 3 services each Sunday.

<u>**Birth to Age Three**</u> – Our new baby ministry provides faith formation support to families with babies and young children. Frolic is a three-year digital home nursery program that helps parents start faith formation along with the physical, intellectual, and emotional development of their child. Materials are emailed to families monthly. Families are presented with a faith bag at baptism.

<u>**Bible Ministry**</u> – Bibles were given out to the Three-year old's, who received <u>The Beginners Bible</u> and the Third Graders, who received the <u>Deep Blue Kids Bible</u>. Parents presented the bibles to their children during worship services.

<u>GIFT (Growing in Faith Together) Ministry</u> – This ministry plans events for children aged three through grade five and their families. Events are scheduled throughout the year included Blessing on the Backpacks, our Easter Egg Hunt, Paint Some Pottery ice cream bowl painting, and Trunk or Treat. During God Work's Our Hands, we assembled Snack Packs for Laundry on Linden. We ended the year with an Advent Workshop "Cookies and Cocoa". A great big "Thank You" to all the volunteers who help support these events throughout the year and we look forward to a great 2024.

Youth Ministry and Youth Education

Background - Our youth program continues to grow. We had a wonderful year in 2023 filled with faithforming and fun activities for youth in grades 6-12. We are very proud of our youth program and acknowledge the congregation has been super supportive of our youth. Thank you. Our youth are very kind, bright, and faith-filled and I am excited for the future opportunities which will allow the congregation to see how amazing they are.

<u>Youth Activities</u> - Our youth program has provided youth in grades 6-12 with opportunities for connection, service, and fun. Once a month we've had activities such as candy making, helping with the Easter Egg Hunt, outdoor games and ice cream, mini-golf, a pizza party, advertising, decorating and volunteering at Trunk-Or-Treat, helping cars park for football games, and a Christmas Lock-In. We have also had a lot of fundraising activities to help finance a trip of 16 youth and adults to New Orleans in July 2024. In June of 2023, our youth stayed at the Kull Center owned by the Ocean City Tabernacle in Ocean City New Jersey and had a great time connecting, giving back to the locals, and worshiping with a gorgeous sunrise. This trip was enjoyed by all who came and will occur again in the summer of 2024.

Cat Camp and Cat Class

Confirmation:

In May, we had a banquet for our confirmands and their families. At the banquet and the next morning for our congregation, our confirmands presented their faith journey projects. Eight excited youth were confirmed in spring of 2023.

Catechism Camp:

This past October, we had 18 people consisting of youth and adult volunteers attend Cat Camp at Bear Creek. Our theme was "Facing Our Fears with God." Youth tackled their worries through strengthening their faith and had a great time!

Catechism Class:

LCHS's Catechism Class started the 2023 year off with the <u>Re:Form Ancestors</u> curriculum for the New Testament. These materials foster a sense of familiarity of the heroes and heroines of faith, while not shying away from some of their more earthy personalities. They started the fall of 2023 studying the life of Martin Luther and his Small Catechism. Students received a copy of Luther's Small Catechism to use in class and at home. They have also received journals as well as devotionals for Advent and Lent to dive deeper into their faith in daily life. Attendance has been strong throughout the year with a consistent average of fifteen to 20 people. While we are sometimes affected by intermittent attendance of youth, the Catechism class is generally blessed with several decidedly consistent youth participants.

<u>Grades 9-12 Education</u> - In 2023, room 114 became the home of High School Connect. We are very excited to have a space dedicated to high school youth. High School Connect is available every Sunday for our youth. It provides opportunities to connect and talk about their lives and how God is present. Both instructors of High School Connect have backgrounds in counseling and have been doing a great job creating engaging and meaningful lessons for our older teens.

<u>College Care Packages</u> - Our youth in Cat Class and High School Connect put together 22 care packages for our members who are in college in the spring. These packages consisted of gift cards, sweet treats, comforts from home, and hand-written messages and cards.

Adult Faith Formation

Background: This is my second year facilitating Adult Faith Formation. The team has seen some changes since last year including a change in the programming of CFL. We have had very successful bible studies, M&M group gatherings, Prime Timers activities, and educational discussions.

<u>Coffee, Tea, Connect</u>: Due to a decline in attendance and technical help in 2022, the team decided to create a discussion-based layout program titled Coffee, Tea, Connect in 2023. This model included speakers that led the congregation in discussion on some Sundays and fellowship discussion topics without a formal leader on others. The team continues to use formative and summative data to determine the next steps for this program. The team also conducted a survey to determine the educational interests of the congregation which has helped them design the topics of formally planned discussions. Congregational members could rate their top choices. Below is the ranking of topics based on responses.

1. LGBTQ+

- 2. Local Charities/Charities our church supports
- 3. Life connection with the bible
- 4. What it means to be Lutheran
- 5. Health and Wellness across the ages.

The current plan for Coffee, Tea, Connect moving forward is the following each month: First/Second Sunday: structured discussions with group leader Third Sunday: breakfast and fellowship Fourth/Fifth Sunday: Fellowship with Discussion Topics

<u>Bible Studies</u>: The team planned a successful Study of James in the spring of 2023 and since then has also planned a study on Romans which received a lot of positive feedback in the fall of 2023. We have seen over a 20% increase in attendance of our Bible Study sessions since 2022. Our Bible Studies use a Discussion-based format that seems to be enjoyed by all who participate. We have even had people come from the community to our bible study that are not members of the Holy Spirit. We look forward to observing continued growth of our future bible studies.

Devotionals: Another responsibility of this Mission team was researching and distributing Advent and Lenten devotionals within the congregation. In the season of Lent in 2023, we used "Water and Spirit" published by Augsburg Fortress. For the season of Advent in 2023, we used "Come, Emmanuel" also published by Augsburg Fortress. The team has received positive feedback from using the devotionals published by Augsburg Fortress. The booklets seem to consist of a great length for people to read each day. The daily message is also faith-filled and relatable. This devotional for the season of Lent in 2024 is "Gathered into One" and is also published by Augsburg Fortress.

Book Group: Each month about 10 people come to book club gatherings. Everyone has a wonderful time of fellowship. The book club meets on Mondays. Throughout this past year, they read and discussed a wide variety of books.

<u>M&Ms Too</u>: Each month about 10-15 people gather together for faith forming conversations. This group continues to welcome new members.

<u>**Prime Timers**</u>: This group celebrates the opportunities for seniors to have moments of growing their faith and fellowship. They have a book group, movie group, and coffee hour as part of their usual programming.

Church Growth Mission Team

In 2023 the Church Growth Mission Team continued implementation of the reorganized process to identify potential new members and to welcome new members into Holy Spirit's faith family. During the year the Mission Team successfully added activities to the new member process. Those activities include:

- the designation of a "point of contact" if requested by new members. A point of contact is a person/family who is/are established members of Holy Spirit. The new member may reach out to their "point of contact" with questions related to the congregation, church activities and groups, family involvement and more.
- two Meet and Greet Sunday morning brunches designed to welcome and meet our new members as well as provide social time for all Holy Spirit members. Note: Holy Spirit welcomed 42 new members during 2023
- two Sunday morning question and answer sessions for potential new members. The sessions
 were headed by Pr. Tami and attended by those considering membership in Holy Spirit as well
 as members of the Church Growth Mission Team, available staff members and council
 members. Potential new members were invited to ask questions regarding Holy Spirit, the
 Lutheran faith, membership at Holy Spirit, or any other related issue.

Late in the summer the Church Growth Team offered a congregational outdoor movie night featuring the movie Ratatouille. An inflatable movie screen was purchased, and a projector was donated. The evening was truly a "test run." The Team learned several important things related to sponsoring a movie night: scheduling in regard to sunset is key, backup equipment is helpful, speakers are needed. A very positive aspect of the evening was the donation of a movie theater style popcorn machine given to Holy Spirit by Denise Rohrbach.

Church Growth led by Pr. Tami, shared a table with our Nursery School at Emmaus Days. Our representatives were able to distribute information about Holy Spirit and our congregation's activities including the Fall Fest/Trunk or Treat. It is our intent to continue to sponsor a table at the Emmaus event.

In October, Church Growth helped coordinate the 2023 Fall Fest/Trunk or Treat event. There were wonderful volunteers from Holy Spirit who helped plan and implement the event. Adult volunteers and Holy Spirit Youth set-up and helped break down on the day of the event. Our volunteers arranged for a community fire truck, sponsored 22 trunks (with treats), provided on-site music, helped with crafts, tattoos, s'mores, and games; not to mention grilling hot dogs and supplying drinks. Trunk or Treat 2023 was a huge success, attended by more than 300 children, adults, and volunteers. It was a great afternoon and a great outreach activity!

Long range issues to be addressed by Church Growth continue to be community involvement and activities, congregational visibility as well as congregational growth.

Striving to support God's Mission, the Outreach Mission Team keeps focused on how it might be best for our congregation to serve our neighbors. Needless to say that focus includes a variety of specific appeals, collections, services and partnerships. A focus that includes the lonely and the alone, forgotten and overlooked, depressed, and abused and includes victims of war and natural disasters, humanitarian crises, and patients lacking resources for needed medical procedures.

In order to provide support that addresses our neighbors' real felt needs, it's necessary to develop partnerships with those "in the know". Our specific partnerships with the numerous organizations and agencies we work with can also be found in the newsletters. Our 2023 outreach partners included the Evangelical Lutheran Church in America (ELCA), Northeast Pennsylvania (NEPA) Synod, local churches and businesses, community organizers, hospitals, universities, numerous not-for-profit humanitarian community agencies, shelters, food banks, and advocacy agencies. Our outreach also includes opportunities to build relationships with the surrounding community through invitations to join us for specific events and services at the church and to use our property to support outreach activities.

Members of our congregation understand the importance of outreach and participate whenever they can. The many opportunities presented and supported throughout the year are a result of The Lutheran Church of the Holy Spirit. That includes all of us - our members, pastors, staff, numerous church groups and committees, nursery school, Sunday school, Vacation Bible School, and the many outreach activities of our young adults. We all come together as members of the One Body of Christ supporting God's Mission, loving him and our neighbors. Outreach - Bloomin' Faith Flower Ministry

Through a small bouquet of flowers, Bloomin' Faith shows care and concern for the members of LCHS who are shut-in, ill or grieving, and also shares happiness and joy with members who are celebrating milestones. Flowers (especially unexpected ones) brighten a person's day and serve as a reminder that someone cares and is praying for them. The Bloomin' Faith ministry at LCHS is held on a monthly basis. Pastor Tami determines the recipient list, taking into account the number of delivery people available. Eight to 16 bouquets are delivered each month.

In 2023, 165 bouquets were delivered January through December to our new members, fifth graders (for their first communion), confirmands, members grieving loved ones, members recovering from surgeries or other illnesses, and members celebrating birthdays and anniversaries. Mini bouquets of dried flowers were delivered by the Eucharistic ministers in February to our shut-in members.

We have been blessed with donations from members, both monetary and physical - flowers and foliage from their gardens. This year, we began arranging bouquets at church on Friday mornings, and enjoy the fellowship of 1-4 additional arrangers. Thank you to our faithful volunteers who spend their Saturday morning once a month delivering the bouquets, and to Brenda Truhe and Deb Smith who coordinate the deliveries.

Our prayer continues: that this ministry gives witness to God's love and abundance through flowers, and we continue to grow in faith through participants, donations, arrangements, and deliveries.

In a fabulous outpouring of generosity from members of Holy Spirit, the following funds were sent: ALMC NICU - \$4,320; Plaster House - \$1,000; and Widow's Might - \$1,443.

In May, a concert by Jon Satrom resulted in hundreds of dollars from free-will offerings going to the Bresma orphanage via the Hearts for Haiti organization. Monies are used to procure milk and other food for the young children at that orphanage.

In October, the Director of The Kafika House (formerly The Plaster House) visited Holy Spirit to discuss the programs for preparing children for surgeries for their correctable disabilities and recovering from those surgeries. The expanding program now serves over 1200 children a year. The Director expressed great appreciation for the contributions received from Holy Spirit over the last several years. A check for about \$750 from Holy Spirit to Friends of the Kafika House was sent in November, resulting from parking proceeds at Holy Spirit during Emmaus football games.

At the end of November, the Love for the Least campaign began, to raise additional funds for the treatment of babies at the Arusha/Selian Neonatal Intensive Care Unit. Almost 400 babies are served every year using low cost but effective treatments.

The planning for the January 2024 Global Missions Sunday is underway. The theme will be on local organizations that collect and distribute medical equipment and supplies to underserved health care clinics in the U.S. and overseas.

The reconvened team began review of staff roles and responsibilities, made updates to the observed holiday calendar in the Employee Handbook to better align with Synod holidays (added Martin Luther King's Birthday and President's Day and removed the Holiday of choice) and recognized staffing changes related to our Operations Manager role (departure of Chris Carter and Bob Mueller and the hiring of Nadine Hohe).

As an expression of thanks to our staff the Mission Team provided surprise treats for the staff meeting in November. Additionally, a Holiday luncheon was planned during the holidays and gift cards were given on behalf of the congregation with thanks and appreciation for all that they have done.

Technology Mission Team

The team is tasked with enabling the congregation through technology as it pursues its mission. That includes planning, procuring, and installing new technologies. It further encompasses administering, maintaining and supporting existing technologies and providing a productive technical environment for our staff and volunteers. Among the resources managed by the team are: 20 PCs, 7 printers, 1 physical and 2 virtual servers, the contributions kiosk, our private and public networks and cabling, the Nave audio-visual systems, the phone system, the church's data, all software, the website and social media presence, and numerous other pieces of audio-visual equipment. The team members include: Paul Bashus, Chris Carter, Mark Casciano, John Letts, Bill Newill, Chris Pirrotta, Eric Rhyder, Justin Scheetz, Marian Schneck, Pete Schneck and Bob Stevens. Nadine Hohe now represents the staff on the team, and John Osenbach is the Council representative.

The most obvious improvement to our technology this year has been the maturing and expansion of the Sunday Production Team. The team has evolved the complex audio-visual and Zoom systems installed during the building expansion efforts into a very stable environment supporting the three services each Sunday along with special services. Several people have joined the team, although the effort very much requires additional volunteers to even the load on team members.

After an exceptional number of changes to our staff in 2022 due to retirements and new staff members, this year was more stable. PCs and phone systems were set up for Bob Mueller, Dean Black and Nadine Hohe and the nursery school move to the lower level was accommodated. A significant amount of old equipment replaced during the building expansion was recycled as hazardous waste.

The most significant challenge facing the Technology Mission Team is finding manpower to support the expansion of the technologies employed. Besides the significant challenge of fully staffing the Production Team, the day-to-day support for the infrastructure upon which all our systems run is seriously endangered by a lack of people. Given the increasing unavailability of people to respond to and prevent system failures, the Mission Team initiated a study of our support options. After looking at other congregations' approaches to technology support and reviewing proposals from a number of providers, the Team proposed partnering with a local Emmaus firm to assist in day-to-day support. In addition, a number of projects were approved for 2024 to improve support, streamline the infrastructure and strengthen security. The changes were presented to Council and were endorsed by them.

Beyond the obvious changes the Technology Mission Team maintained the existing software, such as the Shepherd Staff and Access software which manages much of the church's and Nursery School's data, and responded to the on-going stream of hardware issues. Mark Casciano phased into supporting our Shepherd Staff software. Efforts in 2024 will focus on implementation of a number of new projects recommended by the team to streamline and modernize the technology infrastructure and improve security.

Worship Mission Team

The purpose of the Worship Mission Team is to ensure that the people of God at The Lutheran Church of the Holy Spirit gather for worship around the central gifts of Word and Sacrament.

We continue to provide three in person services each Sunday for our congregation, with two of them also on Zoom. "Rejoicing Spirits" continues to be held once a month in person (with masks optional) for differentlyabled individuals and their families and caregivers. In addition to Sunday services in person and on Zoom, opportunities also exist throughout the year for worship at special services which include Lent, Holy Week, Thanksgiving, Epiphany, Advent, Blue Christmas, Christmas Eve, Christmas Eve Day and New Year's Eve Day. All of this requires the efforts of both staff and volunteers to plan and coordinate these services. MEMBER CARE MISSION TEAMS

Faith Community Nurse/Health Ministry

2023 was the year of the Automated External Defibrillator (AED). Thanks to various memorial gifts and donations, we could purchase 3 AED machines for the church. If needed, an AED can be accessed in less than 30 seconds from strategic locations in the church. As a reminder, they are in the hall across from the kitchen, in the narthex next to the coat closet, and at the bottom of the stairs on the lower level between the Speary Cafe and the classrooms.

To maintain a safety standard, I coordinated and arranged two Heart-saver training sessions for volunteers from the staff, council, and ushers. In all, 17 people were trained at no cost to the church or themselves. To cover the cost of training a grant was obtained from the Lutheran Faith Community Nurse Association (LFCNA), an organization that seeks to be the light of Christ as we integrate faith and health in the ministry of parish nursing.

I check all 14 first aid kits, located throughout the church, monthly to restock and keep up to date. The AEDs are checked monthly for proper operation and expiring supplies.

As a member of the LFCNA I attend monthly peer group meetings where ideas are shared, support given and suggestions for improvement are discussed. It is a vital group for resources and education.

The monthly awareness announcements, printed in Holy Happenings, continued for 2023 with the addition of complementary signage posted in the bathrooms.

In May, John Mosovsky, Elizabeth Moessner, and I attended the Lutheran Day at the Capital, sponsored by the Lutheran Advocacy Ministry in Pennsylvania (LAMPa). It was a day of state-wide networking, learning, inspiration, and action on issues that matter.

In September I attended a 3-part seminar titled, *This Is How* We *Die*. This was a lecture given by Barbara Barnes, a hospice pioneer and RN. It was very enlightening and educational and was sponsored and facilitated by the LFCNA.

I meet weekly with the pastors to discuss pastoral care needs and address the concerns of the congregation, doing follow-up phone calls or visits offering support and guidance when someone is facing difficult times.

Eucharistic Ministers

A Eucharistic Minister visits homebound members and provides communion and a friendly visit. I am responsible for keeping the schedule and homebound list up to date and accurate. The Eucharistic Ministry continues with its constant changes and dedicated staff. We say goodbye to Ann Krall, who decided to retire from the Eucharistic Ministers after years of service. Thank you, Ann, for all your time and dedication. Two new members joined the Eucharistic Ministers team. We welcomed Mary Vink and Sheila Huff as new Eucharistic Ministers. They join a dedicated team who do home visits monthly. Thank you to all our ministers, Marlene (and Rich) Feulner, Marilee Oplinger, Louise Metka, Barb Roba, Pr Camp, Pr Tami, and Pr Wimmer

The 2023 Endowment Disbursements:

The General Endowment is invested in the ELCA Endowment Fund Pooled Trust. All of the other endowments are invested in their own individual Vanguard Wellington Fund. This fund generally holds a portfolio mix of 65% stock and 35% bonds. While 2022 was a difficult year for this type of investment mix, 2023 recovered nicely. Among all of the seven endowments invested there were total dividend and capital gain distributions received in the amount of \$22,054.84 and market appreciation in the amount of \$26,258.26.

Balances as of December 31, 2023 as follows:

Finance Mission Team

Nadine Hohe, Operations Manager Bob Mueller, Assistant Treasurer

I took on the newly created Operations Manager position effective November 27, 2023. The Operations Manager combined both the Finance Director and Property Manager positions. I would like to thank Bob Mueller, Finance Director who has filled this role since February 2023 for his time and dedication.

The Finance Team meets monthly on the third Monday of each month prior to the church council's meeting to review the prior month's financial information and discuss any issues. In 2023 we continued to focus on tracking our progress with our budget plan and goals; looking ahead each month by forecasting where we are expected to be at year-end.

We adjust our financial reporting process on an ongoing basis, and the feedback it provides helps us better understand the reliability of variances of current results to budget. The Statement of Cash Flows remains our primary tool in identifying variances. Since simple comparisons to budget may be unreliable or misleading, particularly due to timing issues, the Statement of Cash Flows is updated monthly to help determine if corrective action is needed to head off any year-end surprises.

The monthly financial results and performance to budget continues to be published in Holy Happenings as part of our effort to promote transparency and keep members informed of our financial position.

Results for the Year: We budgeted a deficit of \$20,878 for 2023 and finished the year with a surplus of \$43,885. Budgeted revenue was \$831,679 and actual revenue was \$882,353, a surplus of \$50,674 or 6.1%. Budgeted expense was \$852,557 and actual expense was \$838,468, a difference of \$14,089 or 1.7% to the good.

The **2023 revenue** surplus was mainly due to unpledged revenue up \sim \$30,000 compared to budget, Cash and Non-Member revenue up \$7,800 compared to budget, and a transfer of funds from Spirit Led/Spirit Alive for the mortgage of \sim \$11,000 compared to budget.

The **2023 expense** surplus was mainly due to Investment in People down ~\$10,000 compared to budget, Worship down \$3,372 compared to budget, and Church Growth down \$2,262 compared to budget. Resources for Ministry was down ~\$20,500 compared to budget, mainly driven by Service Contracts and Technology.

Operating Cash Reserve: We began the year with a cash balance of \$70,439. Our surplus of \$43,885 and year end accounting adjustments gave us an available balance of \$114,464, a surplus of \$44,025 for the year.
