\$75,920 - \$16,558 under budget (17.9%)

- Cancellation of February 9 worship services was a contributing factor on this deficit.
- Operating pledged income (\$64,670) was 14.55% under budget.

- Operating unpledged income (\$4,470) was 51.8% under budget.
